Users may also access provider contact information. Providers can post registration links for their various courses.

- 2 Select desired jurisdiction and "Course" as Search Type.
- 3 Enter desired criteria.

USE COURSE LOOKUP?

Change the criteria of your search without having to return to the Course Lookup Search page.

Click on any of the headers in the result set to reorganize how the data is displayed.

An arrow pointing up indicates results are sorted by that column in descending order.

Click again to see an arrow pointing down, indicating that results are sorted by that column in ascending order.

Use the Filter tool to search the result set for certain text.

For example, if you are searching for a particular provider, simply type the provider's name to display rows only containing that text.

If you are searching for a course on a specific topic, type key words in the Filter field to search for that word.
