**STEP 1:** LOOKUP TOOL ON SBS WEBSITE HOME PAGE

Go to www.statebasedsystems.com. There are three ways to navigate to the Lookup tool.



**1. Select Your Jurisdiction:** In the top right, select your jurisdiction. From the options that appear select 'Lookup.'

**2. State Services Launch Page:** In the bottom right hand corner of the screen, select a jurisdiction from the 'State Services' drop down. Select 'Lookup' or 'Licensee Lookup,' depending on what is available on the State Launch Page.

3. Lookup Direct Link: Select 'Lookup' from the home page.
